#### **BASIC INFORMATION**

- 1. All vending requires prior approval. Vending space is limited. First come, first served. Unauthorized vendors will be removed from the event.
- 2. This is an all-weather event. Fees for 'approved' vendors are Non-Refundable unless the event is canceled due to COVID or a state of emergency. Deposits are non-refundable unless you are not approved to vend, in which case the deposit will be promptly returned. **Approved vendors who fail to show forfeit their deposit.**
- Required info: Web presence/website address and/or photos of products and set up, products for sale, list of events where you have previously vended (references).
- 3. Vendor requests must include a deposit\* equal to \$50.00 for Craft Vendors and \$100.00 for Food Vendors (paid through PayPal: pamvtotm@gmail.com) and the signed contract and required documents emailed to baldhippieproductions@gmail.com to be considered. Vendors will be notified by email. \*If not approved, the deposit will be promptly returned. If approved, the balance is due at check-in. **No-shows forfeit their deposit**.
- 4. \*If paying by mail, only checks or certified postal money orders are accepted, payable to "Forest Farms LLC" and mailed to: Forest Farms, 441 Grange Hall Rd., Tionesta, PA 16353.

### Must be postmarked no later than May 15, 2025, to be considered.

- 5. Vendors may **not** transfer their spot to another person.
- 6. While we do our best to prevent multiple vendors selling the same items, we offer no guarantee that ensures exclusive rights to any items.
- 7. Craft vendors are <u>not</u> permitted to sell any food or beverages.

- 8. Vendors supply their own tents / setups and may park and camp behind their booth. You may **NOT** play any amplified music.
- 9. Vendors must check out by 12:00 Noon on Sunday 6/22/2025. No exceptions.
- 10. Vendors must agree to follow all rules and regulations of the festival, the venue, and the state of PA and federal laws. Vendors are strictly prohibited from possessing or selling drugs, weapons, fireworks, or explosives.
- 11. Copyrighted images must be officially licensed merchandise only no bootlegs. Vendors are prohibited from selling any unauthorized merchandise bearing the names or likenesses of any artist performing at the festival.
- 12. ALL displayed merchandise must be all-age appropriate. ID must be required for any adult items.
- 13. Alcohol sales are strictly prohibited.
